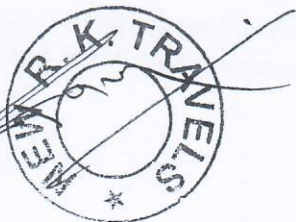

- A security deposit of 3% of the contract amount, i.e Rs.5,58,430/- (Rupees Five lakhs fifty eight thousand four hundred thirty only), as Performance Security Deposit in favour of "MD MPMRCL Bhopal" by way of "Performance Bank Guarantee" or FDR from a nationalized /Commercial Bank . The Performance Security should be valid initially for 730 days, which is refundable after 60 days of expiry of the contract period subject to successful fulfillment of terms and conditions and on receipt of requisite No Dues Certificate from the concerned Departments/authorities. Standard Profarma of the Bank Guarantee is enclosed herewith.
- Sign the contract agreement on non-judicial e-stamp paper as per para 3 of Indian stamp (Madhya Pradesh Amendment) Act, 2015. The cost of non-judicial e-stamp paper shall be borne by you.

Please note that the time allowed for carrying out the work as entered in the Bid is 730 Days, which shall be reckoned from the date of signing the contract agreement. Signing the contract agreement shall be reckoned as intimation to commencement of work and no separate letter for commencement of work is required. Therefore, after signing of the agreement, you are directed to contact the General Manager(HR& Admin), MPMRCL Bhopal for taking and necessary instructions to start the services.
