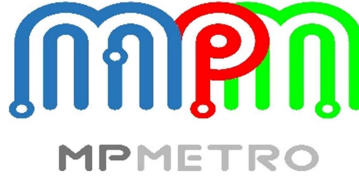

1 GENERAL

1.1 General:

1.1.1 Madhya Pradesh Metro Rail Corporation Limited (“MPMRCL”- “the Employer”) invites online open e-tenders from eligible applicants of all countries, who fulfil the criteria stipulated in Eligibility cum Qualification Criteria, for the Tender Package BH-02: “Design and Construction of Eight (8) Elevated Metro Rail Stations including Viaduct portion within the stations and Transition spans on either side of the stations (AIIMS, Alkapuri, Habibganj Naka, Habibganj, M.P Nagar Zone-1, DB City Mall, Kendriya Vidyalaya and Subhash Nagar)” for Bhopal Metro Rail Project.

All details of the work will be provided in the Tender Documents.

1.1.2 **Source of Funds:** The Employer has applied loans from the European Investment Bank – EIB (hereinafter called “Funding Agency”) towards the part cost of the Project, and intends to apply a portion of the proceeds of the loans for payments under this Contract. - 1.4** Tenders are open to nationals of all countries, who fulfil the criteria stipulated in Eligibility cum Qualification Criteria (EQC). A firm, who has paid tender fee for the tender documents in their name, can submit the tender either as an individual firm or in JV/ Consortium.
- 1.5** The Contract shall be governed by the documents listed in Para 1.3 above along with latest edition of CPWD Specifications, IRS Specifications, National Building Code, MoRTH Specifications, guidelines issued by MoHUA & Other Statutory Bodies.
- 1.6** The Tenderers may obtain further information, if any, in respect of these tender documents from the office of the Director (Technical), Madhya Pradesh Metro Rail Corporation Limited, 2nd Floor, Smart City Development Corporation Limited Office Building, Kalibadi Road, BHEL, Sector A, Berkheda, Bhopal – 462022, Madhya Pradesh, India.
- 1.7** All tenderers are hereby cautioned that tenders containing any material deviation or reservations as described in the "Instructions to Tenderers" shall be considered as non-responsive and is liable to be rejected.
- 1.8 The tenderers shall note the following:**
- i. Notice Inviting Tenders along with tender documents is published in the e-procurement portal <https://etenders.gov.in/eprocure/app>. Tendering processes like download, tender queries, corrigenda, submissions, openings, evaluations, etc. can be done through the e-procurement portal only. All the tenderers willing to participate must be enrolled/ registered on the e-procurement portal.
 - ii. Those who are not already registered, can enrol themselves using the link "Online Bidder Enrollment" on e-procurement portal.
 - iii. Possession of a valid Class III Digital Signature Certificate (DSC) is a prerequisite for registration and participating in the tender submission activities through this e-procurement portal. Digital Signature Certificate

(DSC) must be obtained from any Certifying Authority empanelled with the Controller of Certifying Authority of India, details of which are available on e-procurement portal under the link “Information about DSC”. Issuance of Digital Signature Certificate may take at least seven to ten business days, which may extend up to twenty-one business days in case of foreign applicants. Procedure for obtaining Digital Signature Certificate (DSC) by foreign applicants is available on e-procurement portal under the link “Downloads”. Tenderers are advised to plan their time accordingly and the Employer shall bear no responsibility for accepting tenders which are delayed due to non-issuance or delay in issuance of such Digital Signature Certificates.

- 1.11 Tenderers are requested to visit the website-procurement portal regularly for any Employer's issued clarifications, addendum, corrigendum and/or due date extensions.
- 1.12 The Employer shall not be responsible in any for delay, difficulties and/or inaccessibility of the downloading and/or uploading facility from the e-procurement portal for any reason whatsoever.
- 1.13 The Tenderer whosoever is submitting the tender by his digital signature certificate shall invariably upload the scan copy of the authority letter with the tender submission.
- 1.14 Tender submissions under "Two Cover Bid System" will be made online only as per Clause 5 of Instructions to Tenderer within the prescribed schedule.
- 1.15 Tenders shall be valid for a period of 180 days (both days inclusive i.e. the date of submission of tenders and the last date of period of validity of the tender) from the latest date of online submission of Tenders, as described in clause 4.18 of Instructions to Tenderer.
- 1.16 The Tenderer shall submit an EMD / Tender Security Declaration (as per Annexure – 3 of Instructions to Tenderer) as per Clause 4.19 of Instruction to Tenderer.

- 1.18 The Employer reserves the right to accept or reject any or all Tenders. The Employer is not bound to accept the lowest or any tender and may at any time by publishing a notice in writing terminate the tendering process. No claim in this regard will be admissible.
- 1.19 The Contract will be awarded to the preferred Tenderer whose Tender has been determined to be substantially responsive and compliant to the requirements contained in the Tender Documents and who has offered the Lowest Evaluated Price as per Clause 7 of Instruction to Tenderers, subject to the quoted amount is considered to be acceptable.
- 1.20 Any suit or application, arising out of any dispute or differences on account of this Tender shall be filed in a competent court at Bhopal, Madhya Pradesh only and no other court or any other district of the country shall have any jurisdiction in the matter.
