Pursuant to the Instructions to the Tenderers (ITT), Sub-clause 8.5 and Particular Conditions Sub-Clause 3.10.1, you are required to furnish the Performance Security for an amount of INR 99,80,000.00 (Indian Rupees Ninety-Nine Lakh and Eighty Thousand only) within fourteen (14) days of receipt of the Letter of Acceptance, using the form of Bank Guarantee for Performance Security included in Annexure – 6 of the Instructions to Tenderers.

You are also informed that you have to execute the Contract Agreement within twenty-one (21) days from the date of receipt of the Letter of Acceptance.

It may please be noted that until a formal Contract Agreement is executed, this letter shall constitute a binding Contract between yourselves and Madhya Pradesh Metro Rail Co Limited.

The Commencement Date shall be 21 days after the receipt of Letter of Acceptance.

You shall ensure full compliance with the relevant tax laws with regards to this Contract and shall be solely responsible for the same. You shall keep the Employer fully indemnified against your liability of tax, interest, penalty etc., whichever may arise.

You are requested to submit the Power of Attorney (s) and Board Resolution (to be duly notarised by notary public) in case of any change of authorised personnel since submitted along with the tender submittals.

This Letter of Acceptance is sent in duplicate. You are required to return one copy of it duly signed by the Authorised Signatory on all pages indicating "Unconditional Acceptance" thereof so as to reach the undersigned within one week of issuance of this letter. In case of no response within such time, this Letter of Acceptance shall be considered as deemed accepted unconditionally.

The General Consultant to the Employer will act as the Engineer for this Contract.
